#### **DIRECTOR OF OPERATIONS AND EDUCATION REPORT – Brad Seward**

- **A.** DNR Inspection Report Bert Noll from Iowa DNR Field Office 6 conducted a compliance inspection on August 16<sup>th</sup>. I have handed out a copy of the inspection report, but the inspection report can be summed up best by the statement at the end of the report saying the landfill overall appeared to be in general compliance with the operating requirements.
- **B.** ISOSWO IRA Conference in Bettendorf October 3-5 The ISOSWO and IRA Fall Conference will take place at the Isle Hotel in Bettendorf on October 3<sup>rd</sup> -5<sup>th</sup>. I plan to attend and have a report for the board in October.
- C. Wishcycling Presentation September 16 Next Friday I have a presentation on recycling contamination caused by Wishcycling or recycling something that is not recyclable because somebody thinks it should be, but actually the material is not accepted for recycling. For instance, Styrofoam. That presentation for the Friday Study Club is in DeWitt at the Central Community Historical Society and Museum.

#### **ENGINEER SITE REPORT** – Andrew Phillips of Evora Consulting

Seeding in the back that Rittmer has started growing. Looks good.

Flow meter at leachate lagoon is in. It's recording data.

Post closure update: We did walk over Welton site. Small area that needs some touch up rock. Green and lush cover. Looks good. Based on what DNR comes out and sees and based on data, the West Site could go into the Environmental Covenant phase. That would be a document of understanding that it will not be developed or dug into. It would be agreed upon by our lawyer and DNR lawyers. Means only cap would have to be maintained. Sampling could be stopped. Wells could be abandoned. Engineering inspection would have to done once every two years versus four inspections every two years. Cap must be maintained forever, essentially.
